 thereof to my daughter Johanne Maria the wife of August
 Roeschick of Walla Walla in the colony of New South Wales the
 sum of seventy five pounds to my son Johann Gottfried the
 sum of fifty pounds to my son Johann August the sum of
 fifty pounds to my son Johann Gottlieb the sum of one hundred
 and fifty pounds to my daughter Anna Luise the wife of Euarand
 Hoffmann of New Tannunda the sum of seventy five pounds
 to my son Johann Gottlieb the sum of one hundred and fifty pounds
 to my daughter Johanne Christiane the wife of Andreas Becken
 of Walla Walla in the colony of New South Wales the sum of
 fifty pounds to my son Johann Gottlob the sum of one hundred
 pounds and to my son Johann Michael the sum of one hundred
 pounds and the then remaining balance of any I request my
 said Trustee to divide equally amongst all my aforesaid children
 And I hereby appoint nominate and constitute the said
 August Rueschick of Tannunda Blacksmith Executor of this my
 Will and hereby revoking all former or other wills by me heretofore
 made I do declare this to be my last Will and Testament In
 Witness whereof I have hereunto set my hand this nineteenth day
 of June in the year of our Lord one thousand eight hundred
 and ninety - I Arnold signed and acknowledged by the said
 Johann Gottlob Arnold the Testator as said for his last Will
 and Testament in the presence of us being present at the same
 time who at his request in his presence and in the presence
 of each other have hereunto subscribed our names as witnesses
