

THIS IS THE LAST WILL AND TESTAMENT of me JOHN ERNEST ARNOLD of 610 Olive Street Albury in the State of New South Wales Fruit and Produce Merchant.

1. I HEREBY REVOKE all former Wills and testamentary dispositions.

2. I APPOINT my sons ERNEST NOEL ARNOLD, JOHN WILLIAM ARNOLD and EARLE GEORGE ARNOLD Executors of this my Will and Trustees of my estate.

3. I GIVE AND BEQUEATH unto my wife CHARLOTTE ARNOLD:-

(a) The entire proceeds of policy of insurance on my life with the Colonial Mutual Life Assurance Society.

(b) An annuity of £1,040 during her lifetime and I direct that this shall be payable to her in advance by ~~xxxxxx~~ instalments of £80 at intervals of four weeks.

These bequests shall be free of all probate death and estate duties.

4. I GIVE AND DEVISE my freehold property known as "Wawee" situate at 610 Olive Street Albury being the property in which I reside unto my Trustees UPON TRUST for my said wife during her life and upon her death for my said three sons as tenants in common in equal shares. I direct that during the lifetime of my said wife my Trustees shall pay all rates taxes and insurance premiums in respect of the said property and shall maintain the same in good repair to the satisfaction of my wife and that all moneys so paid and expended shall be borne by my residuary estate.

5. I GIVE DEVISE AND BEQUEATH all the rest and residue of my estate of whatever nature and wherever situate unto my said three sons as tenants in common in equal shares and without limiting the generality of the foregoing provisions I DECLARE that the same shall include specifically:-

(a) My one half share estate and interest in freehold land and premises in Macauley Street Albury upon which stands a bulk store.

(b) All money in any account in my name in the Commonwealth Savings Bank Albury.

(c) All money in Current Account with the Commercial Banking Company of Sydney Limited Albury.

(d) All Commonwealth Bonds.

(e) My share and interest in the partnerships of G.G. Arnold & Sons and E.N. Arnold & Co.
