Purchase Number 1

Purchaser Gottlob Arnold of Tanunda
Section Pt Sec 82 (16 acres) Hundred of Nuriootpa
Date 19 May 1853
From Friedrich Hombsch
Sold 4 April 1887

History - Land first granted to Heinrich Wilhelm Gravenhurst of North Adelaide, shopkeeper for £80 who subdivided it. Friedrich Hombsch purchased Pt Sec on 27 November 1850 for £10 and sold it for £32 to Gottlob Arnold.

Sold 4 April 1887

History - Land first granted to Mathias Lange of Angas Park, farmer for £80. He sold it to Julius Ernest Christian Behrens Bockmann of Angas Park.

Mortgage Book 89/108 dated 20 September 1856 - Gottlob Arnold residing near Tanunda - mortgage with Winifred Thompson.

History - Land first granted 9 December 1851. Ernst Friedrich Kruger purchased Sec 7597 on 13th September 1856 for £705

1863 Johann Wilhelm Arnold purchased the land

Mortgage with Charles Beet for £400 at interest rate £10. Discharged mortgage 4 June 1856. 4 June 1867 unregistered mortgage with Edward Kalleske for £200 plus interest.

20 March 1868 Johann Wilhelm Arnold died intestate leaving Carl Wilhelm Arnold, his eldest son and heir in law surviving. 26 July 1870 Decree from Suit No 10 of 1870

11 August 1871 Johann Ehrenfried Arnold purchased the land at public auction for £497

11 August 1871 Transferred part to Carl Friedrich Arnold (Gottlieb's son) of near Greenock

4 April 1875 Ehrenfried Arnold transferred part to Ernst Wilhelm Arnold (Gottlieb's son) of near Greenock

4 April 1878 Ehrenfried Arnold transferred part to Carl Friedrich Arnold (Gottlieb's son) of near Greenock, farmer

11 April 1883 Carl Friedrich Arnold transferred to Ernst Wilhelm Arnold of near Greenock, farmer

1 August 1940 following Ernest Wilhelm Arnold's death it was transferred to his son Bernhard Alfred Arnold (Gottlieb's grandson)

12 August 1965 transferred to Rodney Malcolm (Gottlieb's great grandson) & Margaret Anne Arnold

Purchaser Gottlieb Arnold of Gnadenfrei, farmer
Section Sec 80 Hundred of Nuriootpa
Date 13 April 1874
From David Heinrich Christian Busch

History - 7 April 1884 Section 80 divided into two parts.

One part (C/T 1237/33) transferred to Carl Friedrich Arnold (Gottlieb's son)
23 May 1922 transferred to Friedrich Wilhelm Arnold (Gottlieb's grandson)
On Friedrich Wilhelm Arnold's death on 18 November 1965 transferred to his wife, Agnes Friedericke Arnold. Following the death of Agnes Friedericke Arnold transferred on 12 April 1962 to Sydney Errol Peters and Dulcie Mona Peters (daughter of Friedrich and Agnes Arnold)
Sold 28 May 1970

Second part (C/T 1237/32) 40 acres transferred on 23 May 1922 to Friedrich Wilhelm Arnold (Gottlieb's son)
13 February 1923 Friedrich Wilhelm Arnold became proprietor on the death of Carl Bernhard Arnold (his brother) and it was transferred to Meta Alwine Arnold, Carl Bernard's widow.
Meta leased the property to Friedrich Arnold for 10 years from 1 May 1926.
23 January 1943 transferred to Ronald Percy Arnold (son of Carl Bernard & Meta Arnold)
Sold 12 November 1947

Purchase Number 13

Purchaser Gottlieb Arnold of Gnadenfrei, farmer
Section Pt Sec 87 C/T LVIII/67 Hundred of Nuriootpa at Gnadenfrei
Date 13 April 1876
From Daniel Heinerich Christian Busch

History - C/T 87 LVIII/67 (40 acres) following Gottlieb's death on 14 November 1884 land was controlled by his executors until Gottlieb's wife, Johanne Christiane Arnold died, then on 5 July 1911 transferred to Carl Friedrich Arnold (Gottlieb's son). Following Carl Friedrich's death the land was sold on 18 March 1879.

Purchaser Gottlieb Arnold of Gnadenfrei, farmer
Section Pt Sec 87 C/T LVIII/68 (40 acres)
Date 18 March 1879
From Friedrich Gottfried Ludwig Qualmann

History - 5 July 1911 transferred to Carl Friedrich Arnold (Gottlieb's son) Following Carl Friedrich's death the land was controlled by his executors and on 1 August 1940 transferred to Friedrich Wilhelm Arnold (Carl's son). Friedrich died on 11 February 1961 and the land sold on 7 November 1961.
